


UC Davis Health Urgent Response Protocol: Leased Spaces

Real Estate Development & Management Facilities Planning and Development



* Event Reporter = Requester



Standard Workflow - Detailed

Event Reporter identifies an issue and determines if the location is a leased or owned property.

LEASED

- ↓ Event Reporter contacts REDM Property Manager and/or HS-Property Management
- ↓ REDM Property Manager verifies building status (lease/owned). If owned, issue is sent to PO&M.
- ↓ REDM Property Manager coordinates with the Landlord or Landlord Representative.
- Landlord or Landlord Representative deploys vendors to make repairs. The vendor informs the Landlord or Landlord Rep if parts are needed.
- Vendor notifies the Landlord or Landlord Rep when work is completed. Landlord or Landlord Rep then notifies REDM of completion.
- ☐ REDM updates Event Reporter.

OWNED

- ↓ Event Reporter contacts PO&M
- PO&M verifies building status (lease/owned). If leased, issue is sent to REDM.
- ↓ PO&M deploys technicians to make repairs.
- ↓ PO&M informs the Event Reporter if parts are needed and/or the technician will need to return later to complete any work.
- ☑ PO&M notifies Event Reporter when the work is completed.

If this in an emergency or potential operational impact for leased or owned (sub-leased) properties, REDM coordinates with: *REDM Leadership, Ambulatory AOD* as required Patient Care Services Division, EH&S, FMO, EM, On Site POC, PO&M Director (if needed) to determine if the impact of the unexpected utility system failure requires implementation of the UCDH Continuity of Operations Plan.




